# KOMASKET MUSIC FESTIVAL (KMF) ARTISANS AGREEMENT CONDITIONS

Please carefully read the following and sign at the bottom

1. KMF reserves the right to accept or reject any vendor application.
  2. **Sites will not be determined on a 1st come 1st served basis. All applications will be given equal consideration and the KFM committee will determine vendor selections and locations.** We will inform you of your acceptance or denial the first week of June.
  3. If a vendor arrives and their booth does not conform to the space requested and provided, they will wait until all other booths are set up and then, if possible, be accommodated.
  4. Should a vendor set up in the wrong booth space, they agree to move to the proper location at their own expense and without protest.
  5. **No vendors will be allowed on-site before Friday morning.** If you must arrive before then, please contact the vendor coordinator. The vendor is responsible for his or her own setup, organization and facilities. All vendors will be fully setup by 5:00 pm Friday.
  6. We ask that you **close your booth no earlier than 8:00pm** on all 3 days. After that it is up to the discretion of the vendor to decide when to close. Please be open for business no later than 10:00 am on Saturday and Sunday.
  7. All booths will remain on site until the festival is finished Sunday. At 8pm.
  8. **Vendors are to inform the vendor coordinator if there are any electrical challenges. Where necessary you will be requested to unplug any equipment until a solution can be found.**
  9. The registered vendor shall be responsible for all damages, claims, charges and injuries resulting from or arising in connection with the operation of or vandalism to the concession including all equipment, and agrees to indemnify and hold harmless the Komasket Music Festival and its members, organizers and staff from any such claims and charges including liability arising out of the concessionaires exhibit itself and the actions of the concessionaires employees and/or agents.
  10. The Komasket Music Festival shall be responsible for the general security of the festival premises from 8 pm Friday, to closing time Sunday but shall not be responsible for individual booths whether the exhibitors booth is staffed and open to the public or not, and shall not in any event be responsible for care and control of the exhibitors equipment and property or the equipment and property of third parties used by the exhibitor, all of which is the sole responsibility of the exhibitor throughout Komasket Music Festival.
  11. Any vendor wishing to cancel a booth space must submit their request in writing no later than June 15<sup>th</sup>. Upon approval of KMF committee, the vendor would then be entitled to a 50% refund on all monies paid. There will be no refunds after July 15<sup>th</sup>.
  12. KMF reserves the right to reproduce photos submitted for KMF promotion.
  13. The total booth fee must be paid in full by June 1, to guarantee your spot.
  14. There is a NO DRUGS NO ALCOHOL policy at this site; by request of the Okanagan Indian Band.
